- a) 11-2-05 Letter dated September 30, 2005 from the Regional Municipality of Waterloo regarding Greater Toronto Area (GTA) waste. Council of the Regional Municipality of Waterloo wishes to unequivocally state they are NOT willing to receive GTA waste on any basis.

- b) 11-5-05 Letter dated September 30, 2005 from the Town of Plympton-Wyoming regarding Highway 402 Reconstruction. In a follow up to County Council's motion of July 6, 2005 which stated: "That the Committee support keeping the Highway 402 interchange at County Road #30 (Exit 25 - Oil Heritage Road) open during the reconstruction of Highway 402 between Oil Heritage Road (County Road #30) and Mandaumin Road (County Road #26)" a petition was received, by way of Plympton - Wyoming staff, from the owner of the truck stop on Oil Heritage Road opposing the closure of the ramps at Exit 25. Of course, any detour will involve additional traffic on County Road #22 (London Line) which is already a sore point for a number of residents. Staff, the Warden and the Committee Chair met with the MTO and staff from their consultant. I think that our best option is to continue to air our concerns for those impacted and see if they can be mitigated in a satisfactory manner.

The following recommendation resulted from the County Council meeting of September 7, 2005: "That staff continue to meet with MTO and its consultants in order to satisfactorily mitigate the concerns raised by various parties in respect of the proposed reconstruction of Highway 402 between CR #26 (Mandaumin Road) and CR #30 (Oil Heritage Road) especially the closure of the ramps at Exit 25 (Oil Heritage Road)."

3. Items of Committee Interest

a) Work in Progress

Township of Enniskillen Comprehensive Zoning By-law

A meeting is scheduled with Enniskillen Council on October 18th, to discuss a draft Comprehensive Zoning By-law which combines specific local policies with County-wide policies. During our review we will try to address new provincial policies and look at some of the deficiencies of the current document which has posed implementation problems over the years.

Village of Point Edward Official Plan

Discussions are ongoing among Council, staff and interested property owners in an effort to resolve issues and incorporate appropriate policies into the plan prior to adoption by Council.

Village of Point Edward Comprehensive Zoning By-law Review

Preliminary work continues on this document. We have set up a staff working group to review sections of the new by-law and make recommendations before those sections go to Council for review.

Village of Oil Springs Official Plan

A meeting has been set up with Oil Springs Council for November 8th, to discuss their updated Official Plan which needs to be modified to satisfy new Provincial Policies and increase document clarity.

County of Lambton Nutrient Management By-law Update

Further work on a revised County Nutrient Management By-law is delayed until changes to the Nutrient Management Act Regulations are finalized.

Warwick Official Plan - 5 Year Review

Warwick Council has been provided with a proposed work plan for conducting its five year Official Plan review but has not responded on when it would like to initiate initial steps.

Shoreline Regulations

SCRCA staff have provided some initial drafts towards developing a shoreline policy under Ontario Regulation 97/04, which gives them regulatory authority over shoreline management

areas. It is a goal to have these policies mesh with existing Plympton-Wyoming Zoning By-law policies.

Town of Plympton-Wyoming Lakeshore Zoning

An excel spreadsheet has been produced that automates the process of determining the building envelopes and maximum floor areas permitted on individual lots in the "Environmental Protection Lakeshore (EP-L1) Zone". (These are dependant on site-specific information). Staff is now using it to answer inquiries as they come in and is working to produce a second version that would produce a summary page including what information needs to be verified by the owner and some general cautions about development in the lakeshore area.

Brownfields Opportunities

A previous report to the Committee dealt with the more regulatory aspects of the latest phase of brownfields legislation. A report is now provided which provides information on community improvement and incentive programs available to all municipalities, including a specific proposal in the City of Sarnia as it relates to the County.

b) Official Plan Amendments

i) The Municipality of Lambton Shores Official Plan Amendment # 10

Official Plan Amendment # 10 was adopted by The Municipality of Lambton Shores Council on the 15th day of August 2005 by By-law 58 of 2005. The purpose of this amendment is to adjust the location of the existing "Residential" designation on the property from the end of Beach Street to the end of Lake Valley Grove Road and to change the designation of the lands at the end of Beach Street from "Residential" to "Hazard" and "Environmental Protection". The lands affected by this amendment are presently designated "Residential", "Environmental Protection" and "Wetland". Development shall take the form of a vacant land condominium, with a maximum of thirty (30) single detached dwellings and associated common areas.

A concurrent Zoning By-law Amendment has been approved by council to adjust the location of the existing "Residential 7 (R7) Zone" on the property from the end of Beach Street to the end of Lake Valley Grove Road; change the "Residential-7 (R7) Zone" to a "Residential-6.10 (R6-10) Zone" which will allow a minimum lot size of 2,000m²; and to change the zoning on the area at the end of Beach Street from the "Residential 7 (R7) Zone" to "Environmental Protection – Natural Conservation (EP-NC) Zone".

The Official Plan Amendment as appealed on October 3, 2005, by Lerner on behalf of the owners (Paul Fraleigh in trust, Cartref Enterprises Limited and Timdan Holdings Inc. and for the mortgagee of the property, G.M.S. Mortgage Investments Corporation). Knutsen Planning Inc. filed an appeal to the Lambton Shores Zoning By-law Amendment on behalf of the above-noted owners on September 7, 2005.
