BY-LAW NO. 88 OF 1998

**"A By-Law to Regulate the Moving of Oversize
or Overweight Objects over Highways Under the
Jurisdiction of The Corporation of the County
of Lambton"**

WHEREAS Section 110 of the Highway Traffic Act, R.S.O. 1990, Chapter H.8, as amended, authorizes a municipal corporation having jurisdiction over a highway to grant a permit for the moving of heavy vehicles, loads, objects or structures in excess of the dimensional limits set out in Section 109 or the weight limits set out in Part VIII of the Highway Traffic Act, R.S.O. 1990, as amended.

NOW THEREFORE the Council of The Corporation of the County of Lambton enacts as follows:

1. Before the moving of any heavy vehicles, loads, objects or structures (all of which are hereinafter referred to as "object") in excess of the dimensional limits prescribed in the latest revision of the Highway Traffic Act, R.S.O. 1990, as amended, over any highway under the jurisdiction of The Corporation of the County of Lambton, the owner of the object, or the moving contractor acting for the owner, shall obtain a permit (as shown in Schedule "A" attached), to be issued by the Lambton County Director of Public Works (hereinafter referred to as the "Director"). Any such permit issued shall not be valid on highways other than those under the jurisdiction of The Corporation of the County of Lambton. If other highways are also to be used, permission must be secured from the proper authorities pursuant to the Highway Traffic Act, R.S.O. 1990, as amended.
2. Applications for such permits shall be made in writing to the Director, using the forms in Schedule "A" hereto attached. They shall specify the weight and overall dimensions of the object to be moved, including its transporting vehicle, and shall describe the object and the proposed method of moving it, and shall indicate the County highways to be travelled during the moving of the object.
3. The permit holder or his/her representative shall use the utmost caution in moving any oversize or overweight objects along County highways, and shall comply with

all regulations and restrictions as set out in the permit and in effect from time to time with respect to the moving of such objects. He/she shall indemnify and save harmless The Corporation of the County of Lambton from all loss, damages, costs, charges and expenses of every nature and kind whatsoever which it may incur, be put to or have to pay because of the moving of an oversize or overweight object under a County Permit, and he/she shall promptly settle all claims from Utility Companies or other persons or agencies affected by such moving.

3. Any person found to be in violation of any provision of this By-Law is guilty of an offence and is subject to such fine or penalty as may be permitted under the Highway Traffic Act, as amended.
4. By-Law No. 41 of 1974 is hereby repealed. This By-Law supersedes any other corresponding By-Law of The Corporation of the County of Lambton which, through inadvertence, may not have been repealed.
5. This By-Law comes into force and effect upon finally being passed.
