1. If the loaded height exceeds 4.15 metres (13.5 ft.) Form 10 - Approval of Utility Companies must be signed by Hydro One and applicable Telephone and Cable T.V. company, and accompany this application.
2. If applicable, a signed approval from the local Police Force or the O.P.P. (Form 10) verifying the Police Escort is available must accompany this application. It is the applicant's responsibility to notify the police and arrange the Police Escort at least 7 (seven) days in advance of the move.
3. No Permit will be issued until the proper permit fee and deposit have been paid to the County (cheques payable to "County of Lambton").
4. Any persons found to be in violation of any provision of a moving permit is guilty of an offence and is subject to such fine or penalty as may be permitted under the Highway Traffic Act, as amended.
